## For businesses

### Subsidy program for made-to-measure training programs in digital intelligence

Scale AI offers subsidies to businesses developing computer intelligence training programs with business, technical and science components.

Eligible programs will be reimbursed for 85% of the admissible expenses, up to the first \$100,000, and then 50% of expenses will be reimbursed for the remainder.

This program is specific to Québec and is based on financing from the ministère du Travail, de l'Emploi et de la Solidarité sociale du Québec.

### Is my business eligible for the subsidy?

To be eligible for the subsidy, business must:

- Be registered in Québec (NEQ)
- Be training employees for a position in Québec
- Be providing training in digital intelligence with a training organization

The following are NOT eligible for the subsidy:

- Québec government ministries or organizations whose personnel are nominated and paid under Quebec's Public Service Act
- Political parties or organizations
- Ministries or organizations of the federal government
- Companies where work is currently suspended due to a work conflict (strike or lockout)
- Companies which have not finished reimbursing a prior debt with Emploi-Québec or the Ministère de l'Emploi, de la Solidarité sociale et de la Famille (unless they are respecting a written reimbursement agreement with the Ministry or Emploi-Québec)

## How and when can you request a subsidy?

When you have developed a program which meets your needs, in collaboration with a training organization of your choice, fill out the following form on our website ([ai.ca/formations](http://ai.ca/formations)) and submit your application to the Selection Committee.

There is no deadline for submitting requests. After receiving the submission, your file will be evaluated by our Selection Committee and a response will be sent within a period of approximately four weeks.

## What expenses are applicable for the subsidy?

Applicable expenses include:

- Training events
- Content development and the updating of content to personalize the training to suit your business or target audience
- The integration of acquired learning (depending on the program)
- Office supplies and materials handed out to participants (e.g.: binders, notepads, etc.)
- The reproduction of educational materials (e.g.: exercises, articles, case studies, etc.)
- Copyright fees for the content being presented (e.g.: university case studies)
- Travel, lodging and meal costs for coaches

Please remember to ask for and keep detailed information.

## How will we receive payment for the allotted subsidy?

Once training has been given, you will need to provide the following:

- The final service offer, including the training plan as presented
- A list of participants including the workplace address of each participant
- Training invoices—including a breakdown of eligible expenses
- The total amount of the reimbursement being requested
